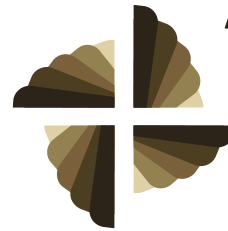

All others are recorded in meeting minutes.</p> <p>The Panel has received a request to provide feedback on possible 'Plen an Gwari' sites identified across Cornwall.</p> <p>It may be possible to include Cornish language entries on the CC mapping. This was previously rejected due to a lack of coordinates. Although it could be a considerable project to include all place names in one batch and verify their accuracy.</p> | |

| | <p>Recent research by KG has linked <diwysyk> 'busy, industrious' to a mistranslation by Nance of <di-> + <gwysek> 'without vice'. (RD1370). It is a cognate of Welsh <gwydiog> / <gwydog> 'wicked, sinful, vicious'.</p> <p>Although the meaning of <diwysyk> has diverged since its use in Resurrexio Domini, it is well-established, and the Board agreed a note of its original sense would be useful.</p> <p>KG will be speaking at the International Congress of Celtic Studies, Utrecht, in late July.</p> | |
